and shown on the map extract annexed hereto.

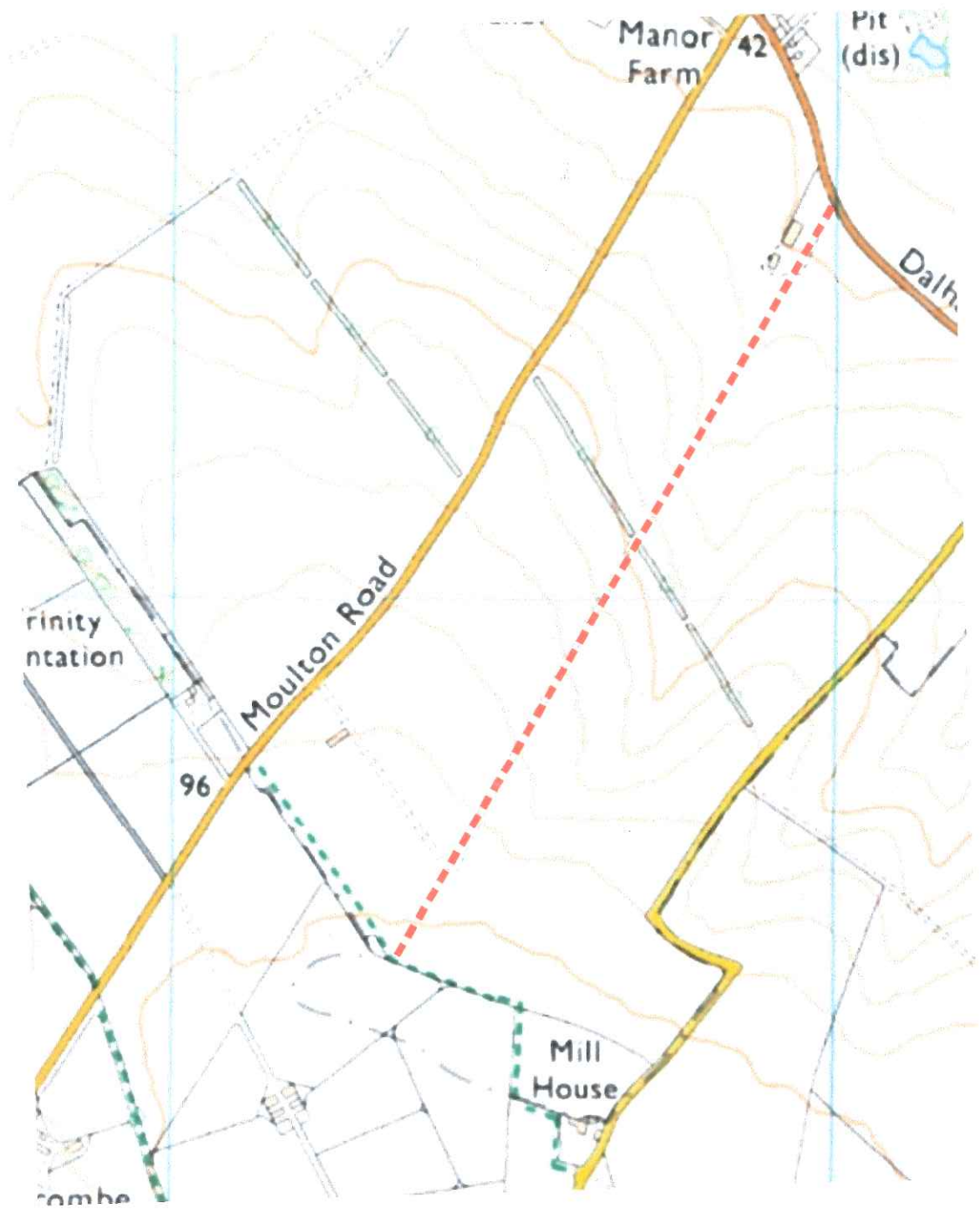

**NOTE:**
