hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding the Public Bridleway which runs from Point A on the application map (OSGR TM 00882 55384) the junction of the application route, City Lane and Great Finborough Byway 47 (Cagman's Lane), to Point B (OSGR TM 01131 55415) the junction of the application route and Great Finborough Footpath 45.
- b) Upgrading Great Finborough Footpath 45 to Public Bridleway from Point B on the application map (OSGR TM 01131 55415) the junction of the application route and Great Finborough Footpath 45, to Point C (OSGR TM 01486 55794) the junction of Great Finborough Footpath 45 and Little Finborough Footpath 6.
- c) Upgrading Little Finborough Footpath 6 to Public Bridleway from Point C on the application map (OSGR TM 01486 55784) the junction of Great Finborough Footpath 45 and Little Finborough Footpath 6, to Point D (OSGR TM 01612 55639) the junction of Little Finborough Footpath 6 and Valley Lane.

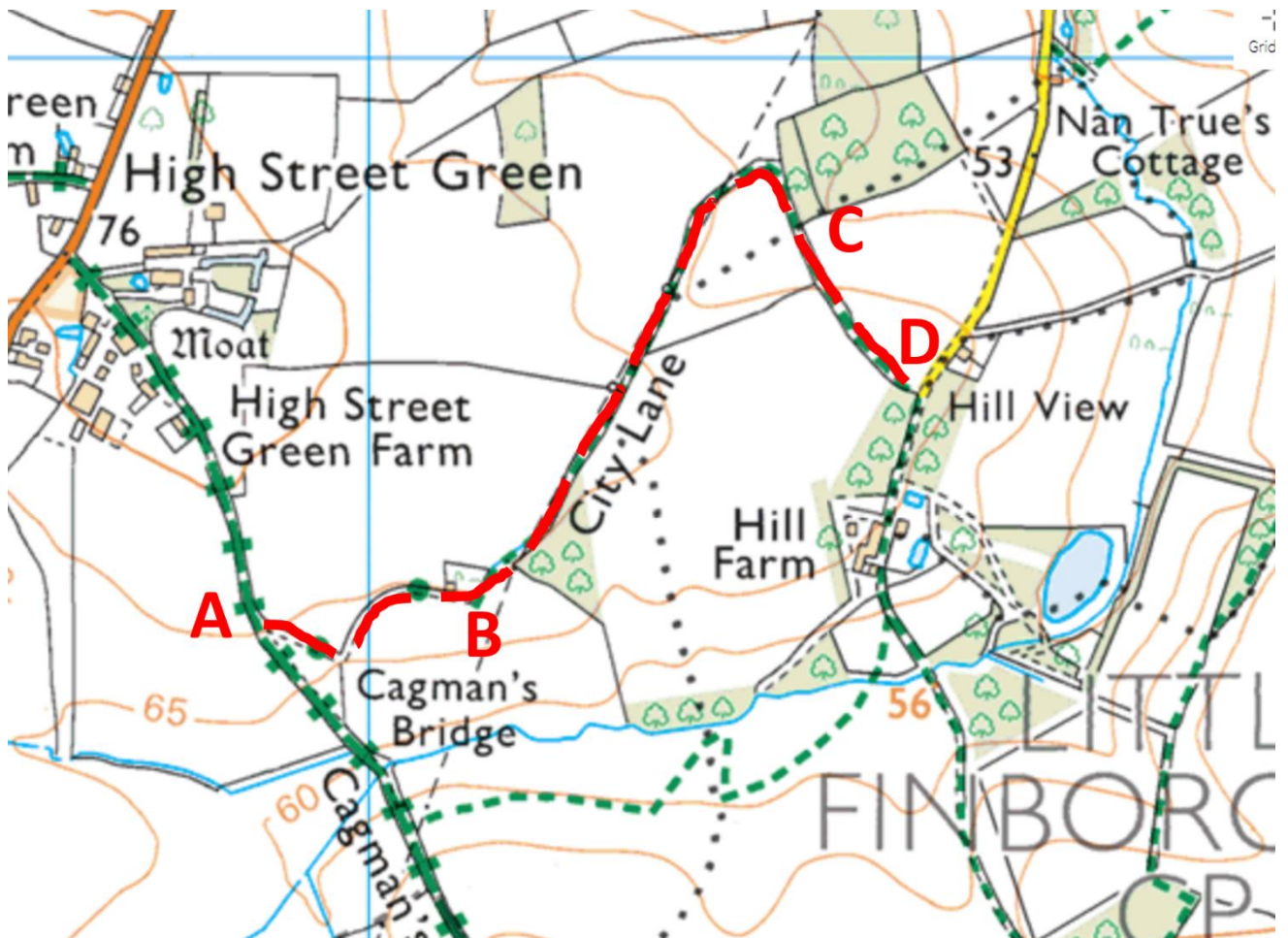
