hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Adding the Public Bridleway which runs from Point A on the application map (OSGR TM 11046 64398) the western termination of the application route at junction with Babb's Lane and Oak Farm Lane, to Point B (OSGR TM 11215 64347) the junction of the application route Babb's Lane and Mendlesham Footpath 15.
- b) Upgrading part of Mendlesham Footpath 15 to Public Bridleway which runs from Point B on the application map (OSGR TM 11215 64347) the junction of the application route Babb's Lane and Mendlesham Footpath 15, to Point C (OSGR TM 114008 64143) the junction of Mendlesham Footpath 15, Mendlesham Footpath 10 and Mendlesham Footpath 14.
- c) Adding the Public Bridleway which runs from Point C on the application map (OSGR 11408 64143) the junction of Mendlesham Footpath 15, Mendlesham Footpath 10 and Mendlesham Footpath 14, to Point D (OSGR TM 11590 63515) the junction of the application route, Babb's Lane and Mendlesham Footpath 11.

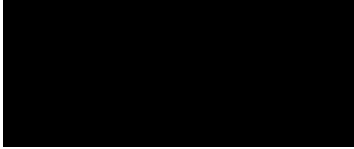

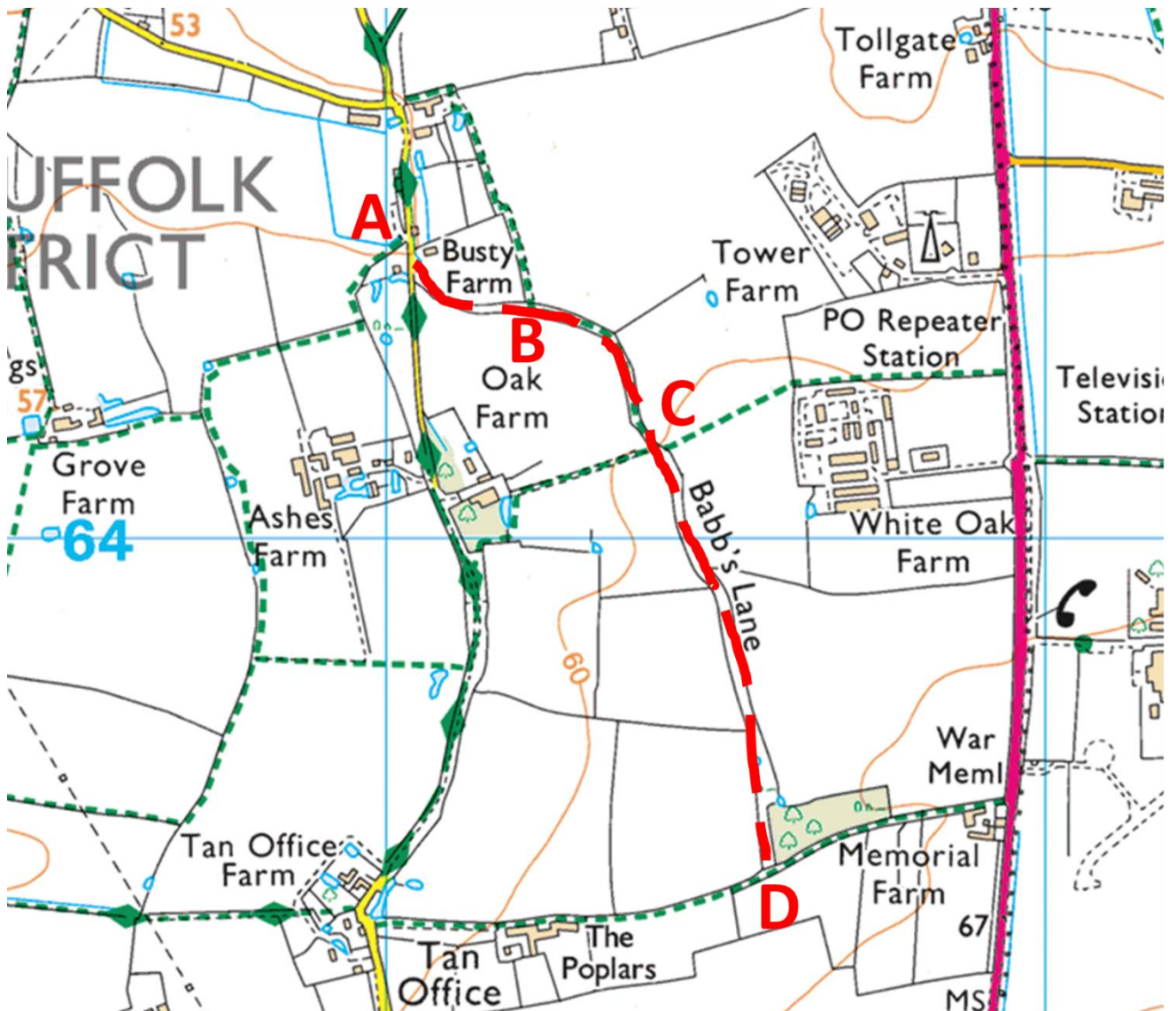
