hereby apply for an order under Section 53(2) of the Wildlife and Countryside Act 1981 modifying the Definitive Map and Statement for the area by:-

- a) Upgrading part of Offton Footpath 11 to Public Bridleway which runs from Point A on the application map (OSGR TM 04824 50210) the junction of the application route, Offton Footpath 11 and Tollmarche Hall Road, to Point B (OSGR TM 04844 50154) the junction of the application route and Offton Footpath 11.
- b) Adding the Public Bridleway which runs from Point B on the application map (OSGR TM 04844 50154) the junction of the application route and Offton Footpath 11, to Point C (OSGR TM 04795 9660) the junction of the application route and Bildeston Road.

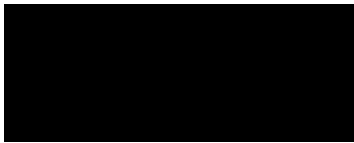

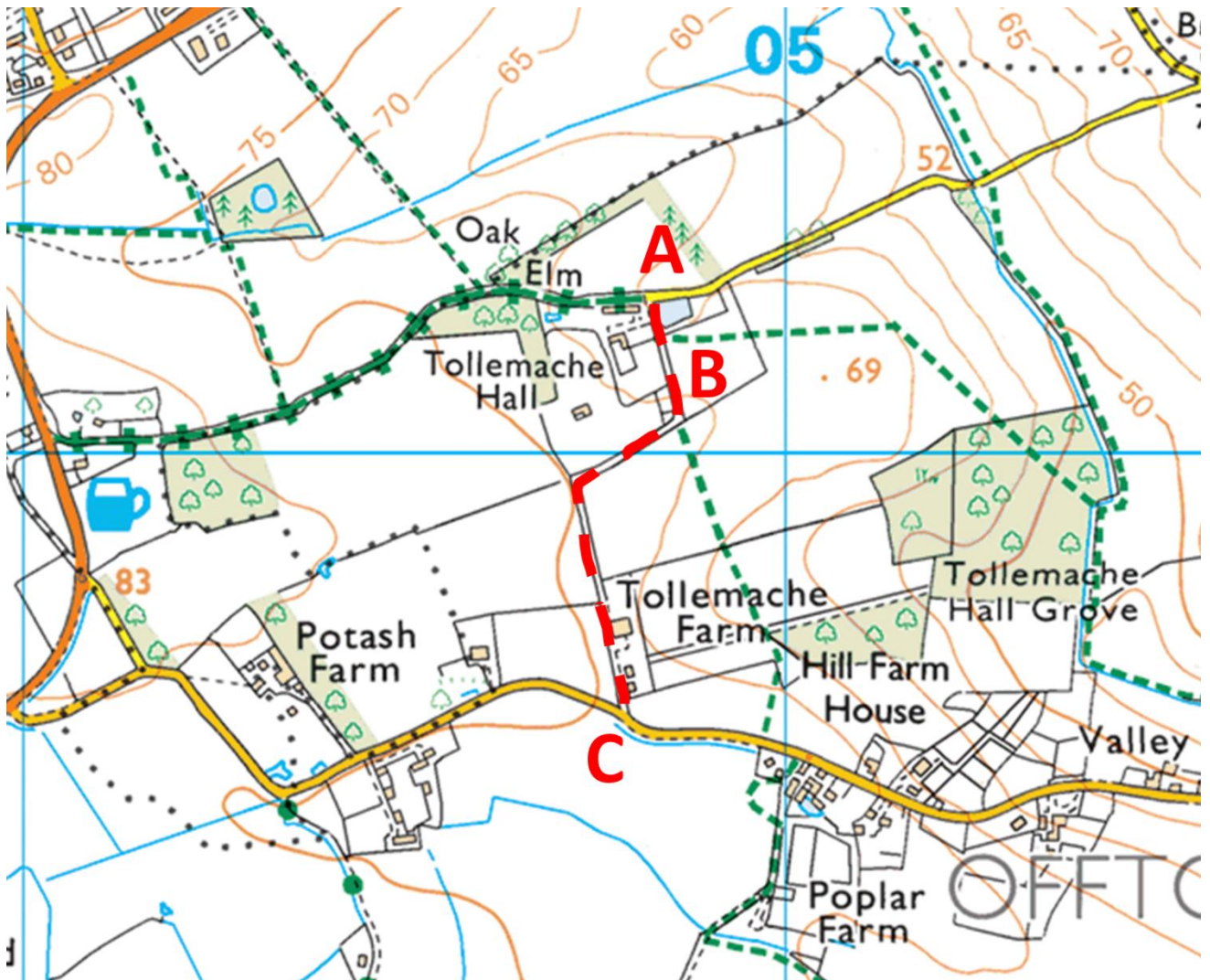
