- a) Upgrading Bedlingfield Footpath 3 to Public Bridleway from Point A on the application map (OSGR TM 18432 68341) the junction of Bedlingfield Footpath 3 and Hall Road, to Point B (OSGR TM 18722 68362) the junction of Bedlingfield Footpath 3 and Southolt Footpath 16.
- b) Upgrading Southolt Footpath 16 to Public Bridleway from Point B on the application map (OSGR TM 18722 68362) the junction of Bedlingfield Footpath 3 and Southolt Footpath 16, to Point C (OSGR TM 19291 68718) the junction of Southolt Footpath 16 and The Street.

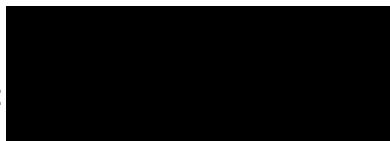

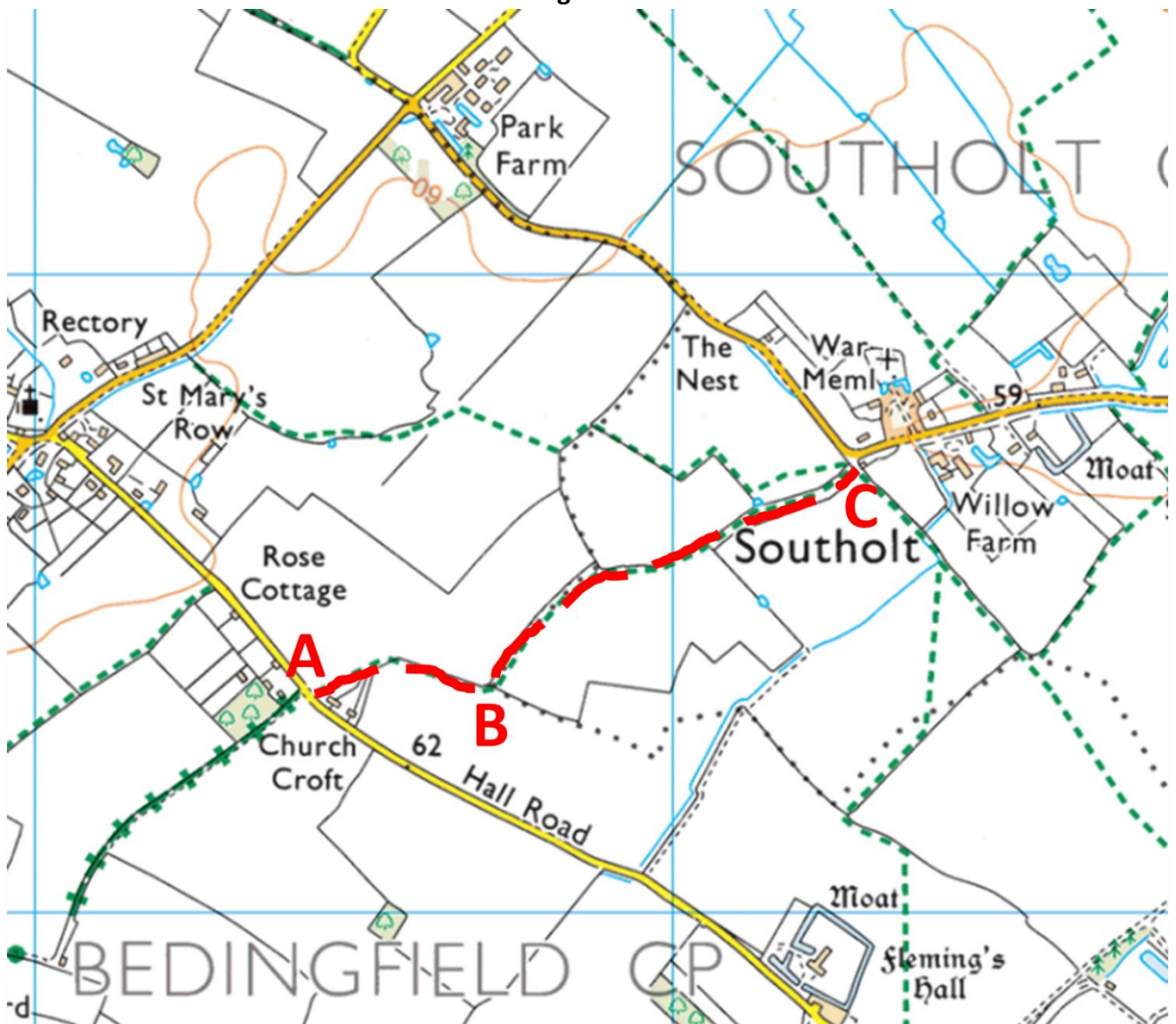
